**MANDATORY SERVICE BULLETIN Z242L/49a**

Technical content of the document approved  
on the basis of DOA Approval No. EASA.21J.110

„SAFETY RELATED“

1. **DATE:** February 15, 2007
2. **MODEL AFFECTED:** Z 242L aircraft of S/N 0490, 0541, 0651, 0652, 0653, 0654, 0655, 0656, 0657, 0658 and 0659 which are provided with the Z 242L Flight Manual without a Doc. No.
3. **SUBJECT:**

After the AMU1 Acceleration Monitoring Unit has been entered into operation on ZLIN aircraft of Z42 series, it has been found out that real intensity of acrobatic operation of some aircraft considerably exceeds original expectations that have been used for determination of operation limits. These aircraft exceed determined total limit load spectra and limit design acrobatic load spectrum.

Described condition can be even worsened by a performance of acrobatic maneuvers in Utility Category. From these reasons, to assure a safety, it is necessary reduce acrobatic maneuvers in Utility Category acc. to FAR Part §23.3 (b)(1) and (b)(2) to: spins, lazy eights, chandelles, and steep turns, or similar maneuvers, in which the angle of bank is more than 60 degrees but not more than 90 degrees.
4. **CORRECTION:** Pertinent revision of accompanying technical documentation.
5. **TIME OF COMPLIANCE:** Immediately after receipt of this bulletin.
6. **PERFORMED BY:** Operator.
7. **COSTS COVERED BY:** No will arise.
