SUBJECT: **Technical inspections of aircraft by Technical Committee of aircraft manufacturer ZLIN AIRCRAFT a.s. Otrokovice**

Operators in Czech Republic perform the technical inspections of aircraft by the technical committee of aircraft manufacturer ZLIN AIRCRAFT a.s. only in factory complex of ZLIN AIRCRAFT a.s. at Otrokovice.

Order of inspection:

It is necessary to order aircraft inspection in writing via Form of order, sent on following address:

info@zlinaircraft.eu

It is necessary to specify aircraft model, registration mark, name of aircraft owner or aircraft operator and total number of flight hours in above mentioned order.

Inspection date:

Date of inspection must be mutually agreed in writing, latest 14 days before date of planned inspection.

NOTES:

1. The aircraft prepared for the inspection must be properly cleaned with all faults removed.
2. The aircraft should have 100 hours inspection or annual inspection performed, which is possible to be done by manufacturer before starting the inspection by technical committee.
3. The manufacturer can remove possible faults found by technical inspection.
4. Technical inspections at the customer:
It is possible to perform the technical inspection at the customer if customer has at least three (3) aircraft prepared.
5. Technical inspections at the foreign customer:
Technical committee performs the aircraft inspection on the basis of mutual agreed date.
